

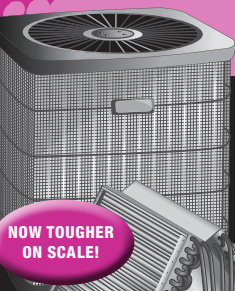
Cal-Brite® Plus is a unique formulation, containing an exclusive surfactant package along with a synergistic combination of acids. Unlike highly destructive hydrofluoric acids that have been used in the HVACR industry, the acids in Cal-Brite® Plus have been specifically developed to tough on dirt, grime and scale, but are less corrosive on surfaces being cleaned than with hydrofluoric acid based cleaners.

DIRECTIONS FOR USE:

1. Goggles, gloves, and other protective garments should be worn when using this product.
2. If the coil is heavily soiled with lint, hair and other heavy soil, use a brush to remove the matter prior to using Cal-Brite® Plus.
3. For normal to heavy soils and grime, dilute 3 parts water to 1 part Cal-Brite® Plus.
4. Shut off the system as well as blowers or air handling equipment prior to cleaning. If using indoors on an evaporator coil, be sure nearby registers are closed. Although the blower was turned off, natural air currents could pick up and entrain droplets of cleaning solution.
5. Spray diluted Cal-Brite® Plus onto coil with a low pressure sprayer and saturate well. Wait 10 minutes, then rinse coils thoroughly with water. For tough applications, reapply Cal-Brite® Plus as necessary. Scaled surfaces often require reapplication.
6. After cleaning, treat coil with Cal-Shield®.
7. Rinse out sprayer, spraying wand and nozzle.
8. When the Cal-Brite® Plus container is empty, rinse, replace cap and dispose of properly.
